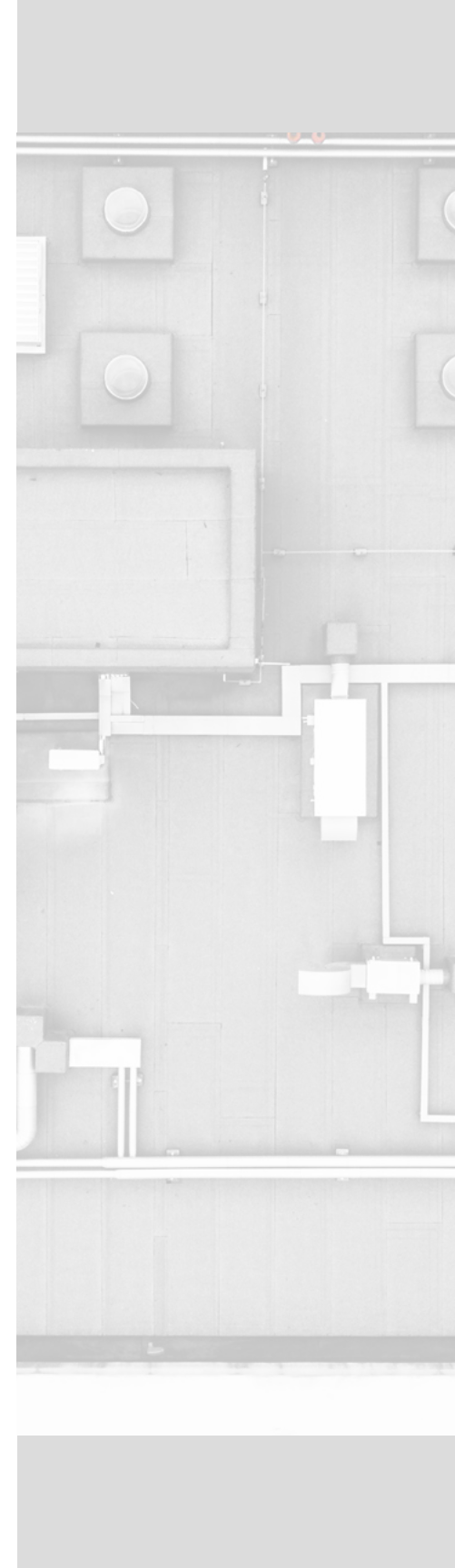

BENCHMARKING SURVEY

EFMR's Advisory Board strives to get a better understanding of what their peers are thinking, what is important to them and what keeps them up at night. After launching our first Benchmarking Survey prior to the 2023 annual meeting, we have gleaned a better understanding of where we stand as an industry. Applying this knowledge is essential to achieving a successful program. With that in mind, this year's conference will focus on the continuation of our benchmarking efforts, sharing of best practices, and integrating these strategies into your own program. Our proposed agenda reflects the real priorities and concerns expressed in the survey, as we continue to work towards true measures of success through benchmarking in our industry. Some of the key takeaways from the 2023 benchmarking survey included:

We are a diverse organization

Over 50% of us represent Financial, Facility Management/Real Estate Provider, and Other (Religious, Construction, Legal, Manufacturing, Port, Environmental Consultant, and Data Center) sectors which enable us to learn from each other while sharing common objectives.

EHS functions report closer to C-Suite and Executive level decision makers.

Approximately half report to a Line of Business Executive level, one third report to the C-Suite, and the rest report up through Legal/Risk Management and Other functions.

There are competing priorities within EFMR member organizations.

Risk management, operational excellence and expense management were the top three environmental objectives, however, expense management directly conflicts with improving risk management and operational excellence.

Based on this feedback, we have created an agenda to address those and other items found the results of the survey.
